The Executive Director's Annual Report

Churches and church leaders, thank you for your continued support and partnership that has allowed the association to stay on task. Bluebonnet Baptist Association's **mission** is to **assist churches**, period. We discipline ourselves to focus solely on that mission, to make sure the association does not supplant or hinder the work of the local church and to respond quickly when churches and church leaders request our assistance.

In fulfilling our mission, the association has set three ministry priorities:

- 1) Assisting churches in starting new churches.
- 2) Assisting churches in church health and revitalization.
- 3) Assisting churches in equipping leaders.

We will continue to budget, staff and partner to carry out these priorities. The staff, officers, Administrative Team and Mission Coordinating Team help me each year to evaluate and improve how we operate as an association. I will do my best to make sure we are proactive in carrying out these priorities.

Generous churches make the ministry of BBA possible through their financial contributions. Though our receipts are down slightly from the previous year, our budgeted ministries are fully funded and prior surpluses have allowed us to designate additional funds to key ministries like church planting, minister care and intern partnerships. We also are able to keep three months of operating funds in our Ministry and Maintenance Reserve fund. That fund self-insures us in case of a large, unforeseen facilities expenditure or a regional weather or other event that disrupts church operations for a time and thus disrupts contributions to BBA. If that were to occur, the M&M Reserve would help us continue assisting churches without interruption. So thank you, partner churches, for making all of this possible through your faithful giving. The association staff strives to exercise good stewardship of the resources you place in our hands.

Church planting is crucial to the Great Commission work in our region and to the continued vitality of the association. There are currently 19 churches in BBA that have been or are being planted through our process. That accounts for one-third of our active member churches and one-quarter of our budget receipts so far in 2023. We have a process that allows any church of any size and level of resources to participate in starting new churches. There is a place for everyone in church planting.

I am currently planning our slate of **Skill Builders** for 2024 with the aid of the Mission Coordinating Team. The topics will be relevant and practical for church leaders. We will continue livestreaming whenever possible and recording the sessions for those who cannot attend the monthly Church Leaders Gatherings in person. We also will continue to assist church leaders through other events like the annual **Church Tax Seminar**, **Oasis Retreats** and **personalized consultations** throughout the year.

In 2023 we officially launched the **Intern Partnership Plan**. We have had eight of these partnerships thus far – three completed and five in progress. The purpose of this ministry is to

create more "on ramps" for emerging ministry leaders. The association assists supervising churches in filling, administering and funding part-time intern positions in the local church. If you have a heart for developing other ministry leaders, then BBA is eager to partner with you.

I want to commend the work of **Linda Gibson** (Ministry Assistant), **Dr. J.K. Minton** (Church Health Consultant), **Dustin Wooten** (Church Planting Consultant) and **Dale Hendrix** (church administration contractor). This associational team does a great job serving churches. They embody the spirit of our mission. It is a privilege to serve the Lord with them.

I hope to see you at the association's **165th Annual Meeting** on Monday, October 9, 2023 at the campus of First Baptist Church in Blanco. We start at 11:30am with lunch and fellowship followed by the annual meeting session. Lead Planter / Pastor David Mathis of Hope Church in Kyle will deliver the annual sermon. Along with our usual business, we will also be voting on an important change to the BBA Constitution. The meeting should conclude around 2pm. I hope you can join us.

Finally, in June of this year I started my 16th year with Bluebonnet Baptist Association. How time flies! Susan and I count it a privilege to serve you. **Thank you** for allowing us that privilege and for providing for us so generously. We look forward to doing kingdom work with you for many years to come.

Church Health Consultant Report

It is a privilege and a blessing to continue serving as the Association's Church Health Consultant under the direction and leadership of Dr. Partain!

We are facing the greatest challenge and opportunity that I've experienced since coming to the Association twenty-six years ago as the population in our area continues to explode. Of course, the growing population creates inconvenient problems: crowded freeways, inadequate city infrastructure to accommodate the traffic, and waiting lines... Our desire for convenience and comfort causes us to long for the "good ole days" when life seemed slower, people seemed familiar, and we were sure to get through the green light before it turned red!

As the Church Health Consultant, I am responsible to focus upon three priorities:

June 26, 2023

Minutes of the Administrative Team Meeting

The BBA Administrative Team met at the BBA office on June 26, 2023. In attendance were Paul Brand (chair), John Minton (BBA Moderator), Jared Walley, Cody Whitfill, Brad Mills, Brice Mandaville, and Robby Partain (BBA Executive Director). The meeting began with prayer led by the chairman.

The one item of business was to discuss a potential change to "Article II – Definition" of the BBA Constitution. That article currently reads: "The Association is a voluntary alliance of independent, autonomous, Southern Baptist churches cooperating with one another in accordance with the articles of this Constitution." The reason for a possible change is the Southern Baptist Convention's (SBC) recent actions regarding churches with female staff members or female lay leaders who have the word "pastor" or "elder" in their titles. The SBC is taking steps toward declaring such churches as "not in friendly cooperation with the convention" and thus no longer SBC churches.

The Executive Director expressed the desire for any such churches in BBA to remain in full cooperation and membership in the association even though they may no longer be SBC churches. He presented some options for how the wording of Article II might be changed to accomplish that objective.

After discussion, the team voted to recommend the following re-wording of Article II (new text in *italics*): "The Association is a voluntary alliance of independent, autonomous, Southern Baptist churches and other churches whose doctrine and practice are consistent with the Association's statement of faith and core values cooperating with one another in accordance with the articles of this Constitution." The motion was made by Jared Walley and seconded by Cody Whitfill. It passed by a 5-1 vote with the Executive Director not voting.

This proposed amendment to the Constitution will be reported to the BBA Executive Board at the association's monthly meeting on July 10 and brought as a motion from the Administrative Team at the BBA annual meeting on October 9.

There being no further business, the meeting was adjourned with prayer led by Cody Whitfill.

August 24, 2023

Minutes of the Administrative Team Meeting

The BBA Administrative Team met at the BBA office on August 24, 2023. In attendance were Paul Brand (chair), John Minton (BBA Moderator), Jared Walley, Cody Whitfill, Brad Mills, Brice Mandaville, Jeff Covington and Robby Partain (BBA Executive Director). The meeting began with prayer led by the chairman.

The team met with Pastor David Peyton of First Lockhart Baptist Church (FLBC) regarding the church's petition to join BBA. After discussion with Pastor Peyton the team voted unanimously to recommend that FLBC be received into full membership in BBA. That recommendation will be brought by the team as a motion to the messengers at the BBA annual meeting on October 9, 2023.

The Executive Director reviewed the year-to-date financial statements for BBA. As of the end of July, the association had a budget surplus for the year of \$3,404.71.

The Executive Director presented a budget proposal for 2024. After discussion, the budget proposal was approved unanimously and will be brought as a motion to the messengers at the BBA annual meeting.

The team discussed SBC President Bart Barber's request that "local associations and state conventions within the SBC family press 'pause' on any ongoing work they may be conducting or motions they may be considering that involve the nature of what it means to be a church in friendly cooperation with sister Southern Baptist churches." Since the team previously approved a motion to amend the BBA Constitution in this regard, the team had a lengthy discussion on the merits of proceeding with that motion versus tabling it for now. The team decided to proceed with the motion as previously approved. That motion will be presented to the messengers at the BBA annual meeting.

The team authorized a 10-year service award for Linda Gibson, BBA Ministry Assistant, and a 15-year service award for the Executive Director. These awards will be paid at amounts defined by the BBA Policy Manual and will be charged to the Association Discretionary designated account.

The team authorized the Executive Director and staff to engage the services of Jim Robertson, CPA for a balance sheet audit of BBA. The cost will be \$4,800 and will be paid from the Association Discretionary designated account. The audit will commence in September at dates agreed upon by the auditor and the BBA office.

There being no further business, the meeting was adjourned with prayer led by Brad Mills.

Frequently Asked Questions about BBA and the Budget

- 1. How is the association's budget formed? BBA has an annual budget that reflects our mission of assisting churches. We budget on the calendar year. Around early August of each year, the Executive Director prepares a budget draft using current-year receipts to forecast the next year's receipts. The staff reviews all personnel, ministry, and administrative expenses and develops budget estimates for the next year based on projected receipts and ministry plans. The Executive Director then meets with the BBA Administrative Team to review the budget proposal and to make changes as needed. Once the Administrative Team approves, the budget is sent to all member churches in advance of the BBA annual meeting in October. The messengers at the annual meeting must give final approval.
- 2. How is the budget funded? The budget is funded primarily by contributions from BBA member churches. There is no set amount for church contributions. Most churches give a percentage of their undesignated tithes and offerings each month. Some churches give a set dollar amount each month or quarter. In addition to the contributing churches, there are some generous individuals who also contribute to the budget of the association. The bottom line is that BBA is a cooperative ministry. The association is funded primarily by the churches for the purpose of assisting churches.
- 3. How is the budget structured? An established church typically has 50 60% of its budget in the personnel category. The rest of the church budget is taken up with facilities, ministry, and administrative expenses. The BBA budget is structured differently because BBA is not a church. Similar to previous budgets, the 2024 budget proposal has 78% of funds in the personnel category, which includes salaries, housing allowances, employment taxes, medical and other insurance, retirement account contributions, and reimbursable expenses for our employees. The rest of the budget is split between ministry and administrative expenses.
- 4. Why is BBA's budget structure so much different than a church's? Remembering that our mission is assisting churches, BBA does not usurp the primary place of the local church in ministering to the community. We do not operate large ongoing ministries as a church does (worship services, Sunday School, student ministry, music ministry, recreation programs, benevolence, outreach events, etc.). We also have low facilities costs. We exist to assist churches; the primary way we do that is through staff time and expertise. Our budget is structured to provide services to churches through associational staff and consultants. The specific ministries we budget for are also church assisting in nature: church planting, partnerships with local churches, and equipping church leaders.
- 5. Are all the association's ministries paid for through the budget? No, and this is another reason that our budget is weighted toward personnel. The association maintains designated accounts that allow us to go beyond our budget in assisting churches. These designated accounts are funded from past budget surpluses plus designated gifts from churches and individuals. These funds allow us to do more for churches in the areas of church planting, equipping and caring for ministry leaders, conferences and retreats, and partnering with churches in various ministries and missions endeavors. In addition, we have a Ministry and Maintenance Reserve designated account that ensures the association's ministry will continue uninterrupted in the case of a large, unforeseen event (such as a wide-scale weather event that disrupts receipts from churches, a large facilities expense like replacing the HVAC system, etc.).

We strive to be good stewards of the Lord's resources that are entrusted to us. We are audited by an independent CPA and our financial reports are public information. The budget is actively managed each year to make sure spending is in line with actual receipts. Notice to the Executive Board re. a Motion from the Administrative Team to Amend the BBA Constitution

The Administrative Team will bring a motion to amend the BBA Constitution at the association annual meeting on October 9, 2023. The motion must be approved by a two-thirds vote of the messengers present and voting in order for the Constitution to be amended (per "Article IX – Amendments" of the Constitution).

Presently "Article II – Definition" of the Constitution says: "The Association is a voluntary alliance of independent, autonomous, Southern Baptist churches cooperating with one another in accordance with the articles of this Constitution."

The motion from the Administrative Team is to amend "Article II – Definition" to say the following (new text printed here in *italics* for clarity): "The Association is a voluntary alliance of independent, autonomous, Southern Baptist churches and other churches whose doctrine and practice are consistent with the Association's statement of faith and core values cooperating with one another in accordance with the articles of this Constitution."

The reason for the proposed change to the Constitution is the Southern Baptist Convention's (SBC) recent actions regarding churches with female staff members or female lay leaders who have the word "pastor" or "elder" in their titles. The SBC is taking steps toward declaring such churches as "not in friendly cooperation with the convention" and thus no longer SBC churches. The above motion, if approved, would allow any such churches in BBA to remain in full cooperation and membership in the association even though they may no longer be SBC churches.

This notice satisfies the requirement in Article IX "that notice of such proposed amendments is given in writing to the Executive Board and filed with the Clerk of the Association at least sixty (60) days prior to the meeting at which the vote will be taken."

One wild, hot, crazy, exhausting, impactful whirlwind

This summer, through our camps and retreats, we witnessed the profound impact in students and adults lives. The worn paths and fields, remnants of well-used equipment, and the towering stack of lost and found items all bear witness to the lasting influence of camp. Our motto, "What happens here changes the World," holds true. In Philippians 1:6, it is written, "He who began a good work in you will carry it on to completion until the day of Christ Jesus." I'm confident that the echoes of this summer will continue to resonate across Texas and beyond, as lives were touched for God's glory.

This year, we have witnessed numerous lives undergoing transformations as we eagerly prepare with excitement for the upcoming fall season! Throughout the summer, we had the privilege of facilitating 9 program camps, welcoming a total of 5,013 students. Additionally, we hosted 15 rental retreats attended by 3,931 students, resulting in a grand total of 8,944 students experiencing the power of God through worship, training, and recreation. Among these students, we saw 1,648 individuals make life-changing decisions, 597 express professions of faith and 414 felt a call to ministry. This fall, we are diligently preparing to host over 3,000 guests, including 14 schools for Outdoor Education, 27 retreats, and 3 program events. May God touch many lives with the gospel this fall.

We've been upgrading our facilities and grounds, including painting all buildings and refreshing the Little Conference Center. We've also added a deck to the Dining Hall and introduced new attractions like Disc Golf and Gelly Ball to enhance the camp experience. The construction of our pond under the Hexapod is almost complete, and we're currently upgrading our zip line. This year, we're focused on refurbishing hotel rooms for better accommodations.

ABOUT THE COUNSELING CENTER

Oakwood Counseling Center was established in 2003 through prayer and a desire to provide Christ-centered professional counseling to Oakwood, New Braunfels, and the surrounding communities. Our Counseling Director and licensed contract counselors offers a program that is clinically professional and distinctly Christian. Each counselor is a dedicated Christian who incorporates a strong balance of both spiritual and clinical care, and each utilizes and teaches proven biblical principles that relate to difficult life situations and issues. Our counselors are all personally committed to provide quality, biblically based care. Treatment includes an initial assessment and evaluation, followed by individual, marital, and/or family counseling. Our counselors are experienced in treating children, adolescents, and adults.

WHAT IS THE GOAL?

Because we believe that God is always involved in the solution, our goal is to help people utilize and build on their faith. Our counselors represent varying Christian denominations, and present scriptural truths that are non-denominational in nature and substance. We believe that the Bible is "inspired by God and profitable for teaching, for reproof, for correction, and for training in righteousness, that the man of God may be complete, equipped for every good work". 2 Timothy 3:16, 17. We do not propose or entertain any philosophy or psychology that does not line up with scripture.

COST: The fee is \$90 for an individual session and \$100 for a marital or family session.

For those who cannot afford the entire fee, the counseling center will provide a "Church Assistance Form" which must be completed by the client and submitted to his or her pastor. The form will provide the pastor with substantial information about the client's financial situation, and it will contain a request from the client asking for a specific amount of financial help from the church. The last page of the form is reserved for the pastor or church administrator to indicate the amount of financial help that the church is able to offer. It should be completed and returned to the counseling center **prior to the first session**.

Please remember that if your church is a part of Bluebonnet Baptist Association you are eligible to partner with BBA in your referrals. When a BBA church refers church members to the counseling center, BBA will gladly reimburse the church of 50% of the charges not covered by the church members. In addition, the association will directly assist BBA pastors, staff ministers, and members of their households who utilize the counseling center.

We recommend that a church initially commit to 6 sessions. After which, the pastor has the option to have the client or the counselor contact them to discuss further counseling needs. The pastor can then make an informed decision as to whether it would be wise to offer continued assistance.
